s = stroke,

z = stop diameter

Calculation dimension x:

y greater than or equal to  $l_2$  -  $d_2/2$ ,

then  $x = d_2/2 - s$ 

(value x for this case see table)

y smaller than  $l_2$  -  $d_2/2$ ,

then  $x = d_2/2 - s - [(l_2 - d_2/2 - y) * 0,123]$ 




